WHEREAS, the lowest bid for the Project was submitted by Pattman Plumbing Heating and Air Conditioning, Inc., whose bid has been reviewed and deemed compliant with the bid specifications, SDA regulations, and New Jersey Public Contracts Law, <u>N.J.S.A</u>. 18A:18A-1 et seq.; and

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby awards the Project to Pattman Plumbing Heating and Air Conditioning, Inc., as the lowest responsible bidder at the amount of \$289,800.00, which includes an allowance for unforeseen conditions of \$20,000.00.

D12. Award Partial Roof Replacement Project to Mak Group LLC -

WHEREAS, a recommendation was made by the Superintendent to the Oradell Board of

Education ('Board") to seek a single contract for Partial Roof Replacement at Oradell Public School (hereinafter "Project"); and

WHEREAS, the Project was properly advertised to prospective bidders in accordance with <u>N.J.S.A.</u> 18A:18A-4 and applicable SDA regulations; and

WHEREAS, on Wednesday, March 27, 2024, the Board received the following bids from potential bidders in accordance with <u>N.J.S.A.</u> 18A:18A-1, et seq., which includes a \$25,000.00 allowance for unforeseen conditions, Alternate 16B- installing new through wall flashing and masonry work, and Alternate 16C – remove and modify existing abandoned block glass:

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby awards the Project to Mak Group LLC, as the lowest responsible bidder at the amount of \$486,558.00, which includes an allowance for unforeseen conditions of \$25,000.00.
