 - Establishment of Capital Reserve Account It was moved by Mrs. Shinevar, seconded by Mr. Spadaccini, upon the recommendation of the Superintendent, in concert with the Business Administrator/Board Secretary, that the Oradell Board of Education adopt the following resolution:

WHEREAS, the Educational Facilities Construction and Financing Act, Chapter 72, Section 57 provides that a board of education or a board of school estimate may, through the adoption of a board resolution, establish a capital reserve account and maintain this account in accordance with GAAP, and

WHEREAS, funds in this account may be used to finance the district's long-range facilities plan required pursuant to subsection a. of section 4 of this Act for which a school district shall be entitled to a spending growth limitation as established pursuant to Section 5 of P.L. 1996, c.138 (C.18A:7F-5), and

WHEREAS, Section 57 provides further that a board of education may transfer undesignated general fund balance or excess undesignated general fund balance to the capital reserve account at any time during the budget year for the funding of capital projects as contained in the district's long-range facilities plans,

NOW THEREFORE BE IT RESOLVED, that the Oradell Board of Education does hereby establish a capital reserve account according to Chapter 72, Section 57 and directs the School Business Administrator to appropriate \$100 for this account and to maintain said account according to Generally Accepted Accounting Principles.
