**MINUTES**

**I. CALL TO ORDER**

The Regular Public Business Meeting of the Oradell Board of Education was called to order at 8:05 p.m. by Vice-president Norian.

**II. FLAG SALUTE**

The flag salute was led by Mr. Spadaccini.

**III. SUNSHINE LAW STATEMENT**

The Sunshine Law Statement was read by Mrs. Norian.

All requirements of the Open Public Business Meetings Law have been met for this meeting of the Board of Education of the Borough of Oradell. Notice of this meeting was filed with the Borough Clerk, posted in Borough Hall and the Oradell Free Public Library, faxed to the Town News, The Record and all persons requesting such notice on August 20, 2004.

**IV. MISSION STATEMENT**

**VIII. SUPERINTENDENT'S REPORT/BOARD PRESIDENT'S REMARKS**

Mr. Mohre made the following comments on the issues highlighted:

- **Dollar & Sense** – A third forum will be held on Wednesday evening, October 13, 2004, at Paramus High School. Our efforts continue to focus on identifying the real issues driving up property taxes while clarifying that schools are not the culprits. He said that the real issues include but are not limited to: unnecessary (and unfunded) mandates, special education/conflict resolution costs, health care plans/costs, and the disproportionate distribution of state aid. As we begin to publicize the

significant impact of S1701 we must emphasize that these tax relief measures are artificial and will result in loss of programs and reduced outcomes for our kids. He noted that we need to clarify the misrepresentations of administrative costs and shift the focus back to Trenton where it belongs.

- **Opening Day** – The first day of school for students is Thursday, September 2, single session days (12:30 dismissal) on September 2<sup>nd</sup> and 3<sup>rd</sup>. OPS will be closed for Labor Day and then full day sessions begin on Tuesday, September 7<sup>th</sup>.
- **Referendum** – He stated that the next edition of OPS Building Blocks, our referendum news bulletin is slated to debut in mid September. In addition, he noted that a Referendum Information Forum is scheduled for Tuesday, September 14<sup>th</sup>, 7:30-9:00 p.m. He said that OPS administration will be meeting with Mr. Charles Koch, architect, and representatives from Turner Construction in the near future to begin finalizing the details of the event.
- **New Staff Orientation** – The Administrative Team will be hosting an orientation for all new staff members on August 25<sup>th</sup> and 27<sup>th</sup>. He explained that the administration and several teacher leaders will be conducting various exercises in order to help all new staff transition smoothly to OPS.
- **School Building Update** – Mr. Mohre commented that the building is looking great, the halls have been painted and the crew has done a fine job cleaning the classrooms. He also said that new area rugs have been purchased for all classrooms and supplies/materials have been arriving daily. We are all looking forward to officially welcoming the staff on September 1<sup>st</sup> and opening our doors to the children on September 2<sup>nd</sup>.
- **Curriculum** – He said that both the Math and Gifted & Talented curricula will be approved tonight.

Mr. Feigenson was absent, and Vice-president Mrs. Norian had no comments.

## IX. COMMITTEE REPORTS/ACTION

### A. BI-BOROUGH - Dr. Westlake, Chairperson

No report was given. The next meeting is scheduled for some time in September at OPS.

### B. BUILDING & GROUNDS - Mr. Gallow, Chairperson

Mr. Gallow spoke briefly about the committee meeting held prior to this Board session. Mr. Mohre explained about the Oradell Police request to place clothing bins on our property to raise money for the DARE program. Board

members were asked to view the bins located at the high school to get an idea of what they look like.

C. CURRICULUM - Mrs. Norian, Chairperson

Mr. Gallow commended everyone who worked on putting the guides together, and talked about the committee meeting held August 11, 2004. Subjects discussed included the proposed Math and Gifted/Talented curricula, the G&T Program Brochure, and the Updated Curriculum Revision 5 Year Plan. Mr. Mohre talked about the Math curriculum in detail, and commented on the G&T brochure.

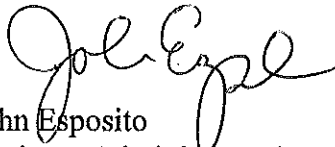
