VI. SUPERINTENDENT'S REPORT/BOARD PRESIDENT'S REMARKS

Dr. Nuccetelli discussed the following items:

• 2012-2013 School District Budget – The administration continues to work on the 2012-2013 budget based on the parameters of the 2% cap and the same state aid that the district originally received in the 2011-2012 school year. The Governor is expected to give his budget message to the State Legislature on February 22. School funding information will be provided after that message. The state aid figures are automatically loaded into the budget software. The Board will adopt a preliminary budget at a Special Meeting scheduled for March 1 at 7:30 pm in

- After School Child Care Lease the board will be considering a lease with the YWCA of Ridgewood for the provision of Child Care Services for OPS students after and before school. The lease memorializes the program that has been offered previously and also provides the district with the opportunity to recapture the costs associated with the program that the district previously absorbed into its budget. The lease is for 3 years commencing with today and has an escalator clause tied to the cost of living or the 2% cap whichever is higher.
- After School NJASK Test Prep Classes this is to prepare our grades 3-6 students for the NJASK scheduled for administration in April-May. The program will begin on February 27 and run for 15 weeks on Mondays and Thursdays after school. It is designed to enhance the skills of our students in testing procedures and content knowledge.
- Dedication of the Science Lab Saturday, March 10 at 10:00 am, the enw science lab at OPS will be dedicated in honor o Wally Schirra. Mr. Schirra's family has been notified and invited to attend. Please mark your calendars and join us for the dedication ceremony which will be followed by light refreshments in the IMC.
- All Day Kindergarten recent events have taken place which have put into question the integrity and confidentiality of the committee that had been created to review this issue. Based on these actions, the committee has been discontinued and all of the documentation they collected has been provided to the Board through the Curriculum Committee. The issue of all day kindergarten will be placed on the March 14th Board agenda for consideration by the full Board. At that time, the Curriculum Committee will present their recommendation as well.

X. OPEN TO THE PUBLIC

Mrs. Nancy Shapiro asked if there would be a vote on an all day kindergarten class since the committee was disbanded. President Watson-Nichols responded that the Curriculum Committee would be making a decision. Mrs. Shapiro said "for the record" Ridgewood still has a half day program and their test scores blow ours away, they have 20% in advanced." The key is the small class size, it is important to keep class the class sizes down. She asked that the curriculum committee consider that in their decision.

Mrs. Michele Puentes asked about NKASK and the number of students we had. Dr. Nuccetelli said it depends how many parents sign up. Mrs. Puentes asked if that information will be made available. Dr. Nuccetelli said probably the week of the 27th.

Mrs. Shapiro asked how long OPS has been doing the NJPASS testing? Dr. Nuccetelli said it has always been in existence. Mrs. Shapiro commented that there should be more teaching instead of testing.

Mr. Scott Duthie asked if Study Island could be put back into the budget. He commented that they had terrific responses from the kids and would love to have it back. Dr.

Nuccetelli said she would look into it. Mrs. Robertson said not all of the grades used it and if 5th grade get it, then 6th grade should also because it is used in the Middle School. Mrs. Goeller said they decided between Study Island and Learnia, but 4th through 6th grades still like Study Island. The daily review is better.

Mrs. Vasalino asked about the OPS test scores that were in the Bergen Record. Dr. Nuccetelli said they were spring 2011 grades 3 through 6, Language Arts, Math, and Science 4th grade. She was concerned about 4th and 5th grade scores and that will be addressed.

Mrs. Perez felt there should be better communication to the parents, whether it is through the media or internet. Mr. Samuel said there is a lot of good information on the OPS website. Back to School night should be put in the students' packet. There needs to be other ways of communicating information to the parents.

Mr. Ferrante asked if we are approving a science program for next year. Dr. Nuccetelli said "yes".
