E3. Approval of Shared Services Agreement with River Dell Regional School District Board of Education – It is hereby moved upon the recommendation of the Superintendent, the Board approves the following resolution:

WHEREAS, the Oradell Board of Education (hereinafter referred to as "the Oradell Board") and the River Dell Regional School District Board of Education (hereinafter referred to as "the River Dell Board") are parties to a shared services agreement pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., whereby the River Dell Board is authorized to solicit

bids for Scavenger/Recycling Services (hereinafter referred to as the "Services") on behalf of the Oradell Board; and

WHEREAS, on April 19, 2016 the River Dell Board received one (1) bid for the Services on behalf of the Oradell Board, submitted by Bella Cleaning and Carting, LLC (hereinafter referred to as "Bella") with a base bid in the amount of \$15,850, representing the combined cost per year in the amount of \$5,150 for the 2016-2017 school year; \$5,300 for the 2017-2018 school year; and \$5,400 for the 2018-2019 school year; and

WHEREAS, the River Dell Board has determined that the bid submitted by Bella is the lowest responsible bid for the Services and the Oradell Board is desirous of awarding the contract for the Services to Bella.

NOW, THEREFORE, BE IT RESOLVED that the Oradell Board hereby awards the bid for Scavenger/Recycling Services to Bella Cleaning and Carting, LLC in the amount of \$15,850, representing the combined cost per year in the amount of \$5,150 for the 2016-2017 school year; \$5,300 for the 2017-2018 school year; and \$5,400 for the 2018-2019 school year. The Oradell Board reserves the right to extend the contract in its sole discretion for two (2) additional years, in accordance with N.J.S.A. 18A:18A-42.

BE IT FURTHER RESOLVED that this award is expressly conditioned upon the contractor furnishing the requisite insurance certificate and performance bond as required in the specifications, together with an executed agreement, as prepared on behalf of the Oradell Board, within ten (10) days of the date hereof.

BE IT FURTHER RESOLVED that the Board President and the Board Secretary are hereby authorized to execute such agreement and any other documents necessary to effectuate the terms of this Resolution.

Approval of Shared Services Agreement for 2016-2017– It is hereby moved, upon the recommendation of the Superintendent, that the Board approves the Shared Services Contract between the Oradell Board of Education and Bergen County Technical Schools. The proposed cost for this service for the 2016-2017 is \$80,375. This is an increase of 3.4% above the 2015-2016 cost of \$77,700.
