Mask wearing at Oradell Public School is optional at all times.

Students have returned to pre-pandemic seating in classrooms with students sitting in pairs, clusters and at tables in larger groups. The district has also increased the number of students in the lunchroom, returning to pre-pandemic levels.

3) Handwashing and respiratory etiquette

At the beginning of each school year, students are reminded of proper handwashing, coughing and sneezing

protocols. The procedures are revisited as necessary in the classroom. If there is a classroom where teacher reminders are not producing desired results, the school nurse visits the classroom to provide instruction, stressing the medical importance to self and other of proper handwashing and respiratory etiquette.

4) Cleaning and maintaining healthy facilities, including improving ventilation ([count] of 1000 maximum characters used)

All classrooms have working windows to provide additional fresh air. Additionally, external air enters all classrooms areas through unit ventilators and/or other HVAC devices. Many classrooms also have additional air purifers. Classrooms are cleaned nightly. The lunchroom tables are cleaned between eating periods.

5) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments

We continue to keep track internally of cases to be alert for possible outbreaks. Cohorts are notified if three or more cases are observe in a specific location and believed to be linked.

The district uses a variety of assessment tools to identify areas of strength and areas of improvement. This helps to inform the work students do during the W.I.N. (What I Need) period each day. The district also applied for a received a high-impact tutoring grant to address the mathematical needs of third and fourth graders. In the area of mental health, we continue to have set periods for social-emotional learning built in each class's weekly schedule. For teachers, we make decisions about how best to use the faculty meeting and professional development time to ensure that their professional and mental health needs are met.
