Coach Steffner was previously at Northern Valley Demarest High School and led the Norsewomen to an exciting season this past winter. The team won their League for the 1st time in school history and finished 18-6. She was nominated for 2013, 2014, and 2015 Coach of the Year. Prior to coming to the Northern Valley, Coach Steffner served as an assistant coach and camp director at Lehigh University. Coach Steffner also played at the University of Delaware, where she was a 4 year letter winner and captain her senior year. She was a stand out athlete at River Dell High school, where she was named 1st Team All-State in basketball and 1st Team All-County in basketball three times. She led River Dell to a County Championship in 1997 and was voted to the Bergen Record's All-Decade and All-Century Teams in 2000. River Dell inducted her into their Athletic Hall of Fame in 2010.
