

Trends and Findings¹

The survey was conducted midway through October, approximately six weeks after the District reopened. Overall, the results reflected positive feelings regarding the reopening plan. First of all, in a District that typically has a response rate of less than 50% on surveys, the response rate of 68% shows that our families are invested and believe that they have a voice to share that will be heard. Our staff response rate was much lower (less than 25%); however, considering how much is on staff member's plates right now, we will try to collect more information at a later date.

With regard to overall views on reopening, 80% of family respondents and 98% of staff respondents stated that while things aren't perfect, the overall structure is working and/or that they trusted administration and the reopening committee to make necessary changes. The most prevalent comment from parents was regarding a desire to increase onsite time. It is important to remember, however, that this survey was completed prior to Oradell Public School having any diagnosed cases of COVID-19.

Other findings include, according to family respondents, that special area classes are more successful and engaging than in the spring. There are still concerns with class size for special areas, length of special area class and amount of Zoom sessions a week a student must attend. With regard to the staff survey, there were concerns that teachers in the hybrid model felt overwhelmed and regarding the cleaning of common areas, specifically copy rooms, lunchrooms and the faculty room.

Next Steps

The Reopening Committee, specifically the School Pandemic Response Team, will meet to consider the several topics.

- When the time is right (considering county transmission rate and occurence of positive diagnosis within the school), what are the benefits and restrictions of possible ways to increase onsite time, including:
 - Turning Virtual Wednesday into an alternating A/B day
 - Extending the onsite day for grades 3-6
 - Moving additional grades to an AM/PM structure (like the one used in K-2)
- Continued review of the hybrid model in grades 3-6 and what can be done to alleviate teacher stress in this model.
- Additional discussion regarding special areas, considering legal requirements of special area classes and researching best practices across the county in this area.
- Developing a clearer set of student expectations and the role of parents during at-home learning time.







Family Survey - Overall Perspective







If in the hybrid program, do you feel safe about your child attending onsite? 511 responses




If in the hybrid program, does your child feel safe at school? 511 responses




Staff Survey - Physical Safety

If in the hybrid program, do you feel safe being onsite? 22 responses




Family Survey - Special Areas








On the Full Virtual Wednesday, my child is engaged with his/her class and classwork. ³³⁶ responses




Family Survey Regarding Instruction - Full Remote Program

For FULL REMOTE students only. My child is engaged with his/her class and classwork. ⁴¹⁶ responses




For FULL REMOTE students only. My child is clear on what he/she needs to do after completing virtual learning hours with his/her teacher(s). 180 responses
