If additional days are required prior to February 1<sup>st</sup>, the BOE will use days starting with February 19<sup>th</sup>, followed by Spring Recess, working forwards from April 15, then April 16, and so on to be used as make-up days. If necessary, the last week of June or the Memorial Day weekend may be utilized to comply with State attendance requirements.
